After many years of planning and hard work by our members, the new ABC Office and Training Facility has opened at 2821 Broadway Blvd. NE, just north of Menaul. The offices and training facility comprise 12,000 square feet and will house the labs and classrooms for ABC Apprenticeship programs. ABC plans to have the labs ready for the fall semester. Three large rooms equipped with high bays and tool cribs will be used by the carpentry, drywall, electrical, sheet metal and plumbing apprentices. WIA Funding Now Open to Current Employees

Workforce Investment Act job training assistance is now available for employers who wish to place a current employee into the ABC Apprenticeship Program. Previously this funding was only available for unemployed, potential apprentice applicants. Employers vetting individuals into apprenticeship are eligible to receive 50% of the apprentice's wages for the first six months of their apprenticeship. WIA funding is also available for customized training that upgrades employees' skills.
